The vessel(s) will be on the premises of the Buffalo Canoe Club for the duration of the work order and/or storage agreement.

I understand that the maximum vessel retention period in Canada without the payment of duty or taxes is normally 12 months for storage and 18 months for repair and that extensions may be possible. I further understand that while in Canada for repair or storage, the vessel may not be used for leisure or any commercial enterprise; it may not be sold or leased/rented and it must be exported upon completion. Lastly, I understand that at the end of the storage period or once my vessel is repaired, it may not be returned back to leisure use or remain in Canada at the end of the CBSA Authorization Period (see below); rather, it must be exported, i.e., returned to the U.S., and then it may be imported back to Canada for temporary leisure use, e.g., the Summer sailing season.

Accordingly, I hereby appoint the Buffalo Canoe Club, my service provider with respect to any storage or repair services for my boat(s), to act as my agent. New 2018 Launch Requirements:

Any boat being stored in the main lot area (West side of the BCC property along the main entrance drive) must have a 2018 launch date prior to or on June 22, 2018. Any boat remaining in the main lot area after June 22, 2018 will be relocated to the East side of the BCC property at the owner's expense. In addition, any boats remaining past the June 22nd launch deadline may forfeit storage space in the main West lot for future storage seasons. If your plans call for a later launch date next season, please notify the Marina Office prior to haul out so your boat can be located in the East lot for the upcoming storage season.
